Subject: - Compliance of Deficiencies relating to Infrastructure & Faculty by the Government Institutes.

Sir,

As you are aware that the deficiencies, evaluated by AICTE web portal based on application filed by institutes on self-disclosure basis, were communicated to the institutes in EOA letter for AY 2018-19. The compliance submitted by institutes were examined by Scrutiny Committee. On examination of scrutiny report it was observed that a large number of Government Institutes had major deficiencies with regard to infrastructure and faculty.

2. The Principal Secretaries of all State Governments vide letter dated 11.02.2019 were requested to take necessary steps to rectify the deficiencies and submit compliance of deficiencies observed by Scrutiny Committee. The compliances submitted by Principal Secretaries of concerned state were placed before 124th Meeting of EC dated 08.04.2019 under agenda item no. 124.03.02. The decision of EC as under:

The EC was informed that appx.595 nos. of Government Institutions are deficient in faculty apart from other deficiencies such as infrastructure, land etc. The EC was also informed about the issue related to recruitment of faculty in the absence of clarity on implementation of reservation quota. UGC has not given directions after an ordinance was issued by the Central Government. However, due to code of conduct, there would be some delay in actual recruitment.

As per 123rd EC decision, State Governments have been written for the compliance of deficiencies.

The Executive Committee deliberated on the proposal of granting Extension of Approval(EOA) to 1321 nos. of Government Institutions who otherwise have deficiencies. After deliberations, the EC decided that based on the commitments received from respective State Governments of compliance of deficiencies, a committee of three academicians be constituted of severity of deficiencies be assessed. If deficiencies are severe in nature, appropriate action, ranging from reduction of intake between 10 to 20% be imposed.

- 3. In view of above decision of EC a Committee comprising of academicians was constituted. The compliance submitted by in respect of institutions run by these State Governments, were examined by Committee. The Committee recommended EOA or reduction of intake appropriately for 2019-20 subject to condition that EVC to be conducted in the month of July,2019 to verify infrastructure & 50% regular faculty. Based on these recommendations all these Government institutes were issued EOA appropriately.
- 4. In view of the above, you are requested to direct all such institutes to be ready for verification of infrastructure, faculties, etc. by EVC.

Subject: Compliance of Deficiencies relating to Infrastructure & Faculty by the Government Institutes.

Sir,

As you may be aware that a large number of Government Institutes have been granted Extension of Approval(EOA) for the A/Y 2018-19 along with the portal generated deficiencies based on self-disclosure which are required to be complied with by the Institutes within a period of 6 months from the date of issue of EOA i.e. April 2018. Further, Institutes having less than 30% admission continuously in the preceding five years have been given 50% reduction in intake for A/Y 2018-19. The concerned RO/AICTE has conducted Scrutiny Committee meeting with regard to the compliance of deficiencies by the Government Institutes. Based on the Scrutiny Committee recommendations, Standing Appellate Committee meetings (SAC) have been held in respect of Institutes who have appealed against the recommendations of the Scrutiny Committee. The Recommendations of Standing Appellate Committee have since been uploaded on AICTE Web Portal indicating the status (i.e. No Admission/Reduction in Intake/Closure of Courses) of Institutes for A/Y 2019-20 depending on the gravity of deficiency.

It has been observed from the Standing Appellate Committee recommendations that a large number of Government Institutes have Deficiencies with regard to Infrastructure and Faculty which are considered to be major Deficiency in terms of Approval Process Handbook norms. It is, therefore, incumbent on the part of the respective State Governments/UTs to take immediate steps to make good the Deficiencies so that these Institutes qualify for grant of EOA for the next Academic Session i.e. in 2019-20.

In this regard, requests are being received by the Council for grant of EOA without any reduction for A/Y 2019-20 on the ground that Deficiencies are being complied without indicating specific time frame for compliance. Further, the requests are not originated from the Competent Authority (i.e. not less than Principal Secretary to the State Govt./UTs). In the absence of stipulation of time limit for compliance of deficiencies/undertaking from the Competent Authority of the State Govt./UTs, it would not be possible to grant EOA with full intake for A/Y 2019-20 to Govt. Institutes ignoring the recommendations of Standing Appellate Committee.

Under the above circumstances, you are requested to take immediate steps to comply with the Deficiencies relating to Infrastructure & Faculty in respect of the Govt. Institutes in your State / UT so as to consider for grant of EOA for A/Y 2019-20 and send a consolidated status report in respect of all the Govt. Institutes having deficiencies as per the enclosed format along with undertaking from the Competent Authority i.e. not less than Principal Secretary prescribing specific time limit to make good the deficiencies. It would not be possible to examine the requests from the State Govt./UTs which are not in the prescribed format/without undertaking from the Competent Authority.
