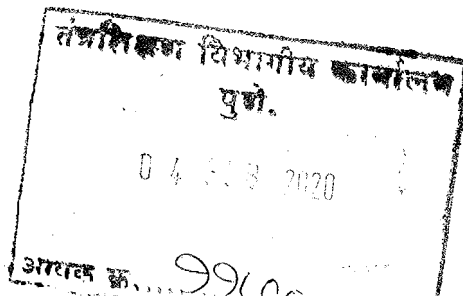
This envelope should contain the following documents. :

- a) Covering letter for submitting the documents on the letter head of the firm, mentioning postal address, contact No., Email address & website address (If available), with name, signature and seal of the firm.
 - b) Firm’s Registration Certificate.
 - c) GST registration certificate / GST No.
 - d) Proof of payment done of GST up to 31st July 2019.
 - e) Technical literature/leaflet of the item regarding specifications make & model of the equipment.
 - f) Undertaking of the bidder for quality and after delivery service and support.
 - g) If the bidder is not a manufacturer, then all documents mentioned above and Authorization / Distributorship certificates from the original manufacturer is required.
- 3) The ‘Second envelope’ should contain the ‘Financial bid/Quotation’ of the item quoting the rates inclusive of all taxes, other charges and F.O.R. Destination in format as per the Annexure attached on the letter pad of the firm.
